

## COVID Safe Expectations

Classroom Learning Expectations	What happens now
<p>Young people are ready to be proud and caring members of their community. They support all of us to <b>be safe</b> by:</p> <ul style="list-style-type: none"> <li>• Washing hands regularly for at least 20 seconds or using sanitiser where this isn't possible.</li> <li>• Maintaining good respiratory hygiene by following – 'catch it- kill it- bin it'</li> <li>• Keeping to social distancing at all times: 2metres without a mask and 1 metre with a mask</li> <li>• Wearing a mask in all areas of the academy outside the classroom</li> </ul>	<p><b>Young people receive positive praise, Excellence Points for good conduct and Teacher Commendation in exceptional circumstances.</b></p>
<p><b>Red (10 points)</b></p> <ul style="list-style-type: none"> <li>• Refusal to wear a mask</li> <li>• Not keeping to social distancing</li> <li>• Touching resources that have been allocated to another person</li> <li>• Refusal to clean hands</li> <li>• Pretending to cough or sneeze on another person</li> <li>• Use of phone within the academy</li> <li>• Dropping tissues or face masks on the floor</li> <li>• Bringing unnecessary items into the academy</li> </ul> <p>Any action judged to be a serious risk of COVID-19 transmission</p>	<p><b>Non-negotiable sanctions:</b></p> <ul style="list-style-type: none"> <li>• AHT to contact parents/carers (same day)</li> <li>• Confiscation of phone/electronic equipment and collection by parents only</li> <li>• Record in planner</li> <li>• Record on SIMS</li> <li>• Supervised lunch</li> </ul> <p>Sanctions Issued by the Executive Headteacher or Head of Secondary only:</p> <ul style="list-style-type: none"> <li>• Fixed term exclusion</li> </ul>
<p>Major incident (15 points): Violations to be agreed by SLT only</p> <ul style="list-style-type: none"> <li>• Persistent refusal to wear a face mask when not exempt</li> <li>• Inappropriate wearing of a face mask</li> <li>• Coughing, sneezing, spitting, spreading bodily fluids on another</li> <li>• Persistent refusal to socially distance</li> <li>• Touching another pupil or adult</li> <li>• Out of bounds or bubble mixing: not within teaching or social zone, waiting on corridors for friends, going to areas of the building without permission</li> </ul>	<p><b>Sanctions to include:</b></p> <ul style="list-style-type: none"> <li>• Formal behaviour meeting with parents</li> <li>• Police referral</li> <li>• Behaviour placement</li> <li>• Managed move</li> </ul> <p>Sanctions Issued by the Executive Headteacher or Head of Secondary only:</p> <ul style="list-style-type: none"> <li>• Fixed term exclusion</li> <li>• Permanent Exclusion</li> </ul>
